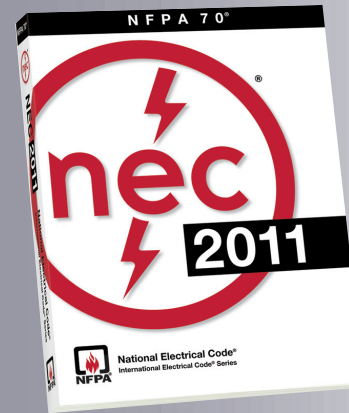

2011 NEC Code Changes Seminar

'How will the Changes in the 2011 NEC Impact your Business, Customer, Design and Installation of your next Electrical System?'

INSTRUCTORS

The instructors for this program bring you information that is direct from the code making panels as all currently serve on a code panel. The instruction team will also bring broad perspectives from a building officials background, manufacturers background and contractors background.

L. Keith Lofland. Keith is the Director of Education, Codes and Standards for IAEI. He served as IAEI's Seminar Coordinator for 8 years and has been an International Instructor for IAEI since 2000. Keith represents IAEI as a member of Code Making Panel 9 for the National Electrical Code. He also is a member of UL's Electrical Council. Prior to his position with the International Office of IAEI, Keith spent 16 years with the City of Garland (Texas) serving as their Chief MEP Inspector. Keith worked for some 13 years for various electrical contractors in the Dallas, Texas area as a journeyman electrician before he accepted a position with the City of Rockwall, Texas to begin his 21 year career as an electrical inspector. He holds a Master Electrician license for the State of Texas. He also has obtained Electrical Inspector certifications from IAEI, NFPA/IAEI, and ICC. Keith served for 4 years as Chairman of the Dallas County Regional Electrical Advisory Board, which administered electrical exams for over 40 metroplex cities in the Dallas area. He served as Chairman of the Texas Chapter of IAEI in 1989 and served as the Secretary/Treasurer for the Texas Chapter-IAEI for 10 years from 1995-2004. Keith received the "Building Official/Building Inspector of the Year" award in 1999 from the Construction Research Center-University of Texas at Arlington.

Alan Manche. Alan is the Director, Industry Standards for Schneider Electric / Square D in Lexington, Kentucky. He has been with Square D for 18 years holding positions in product engineering and product certification for busway, panelboards, switches, and metering equipment. Alan, a registered professional engineer in the state of Kentucky, serves on Code Panel 10 of the NEC and was formerly a member of CMP 8 and CMP 20. He also serves on the NFPA 110 Technical Committee – Standard for Emergency and Standby Power Systems, NFPA 70B Technical Committee – Recommended Practices for Electrical Equipment Maintenance and NFPA 73. He is actively involved in the development of UL, CSA, and NEMA standards and serves as the Education Chair for the IAEI Western Section.

Tim McClintock. Tim is the Chief Building Official/Electrical Inspector for the Wayne County Building Department in Wooster, Ohio. He has been with Wayne County for the past 15 years. Tim currently holds certification with the State of Ohio as a building official, residential building official, electrical safety inspector, electrical plan examiner and building inspector. Tim serves on two NFPA Technical Committees representing the IAEI; Code Making Panel 12 for NFPA 70 – The National Electrical Code and Chair of the Technical Committee on Electrical Equipment Evaluation, which is responsible for NFPA 790 and 791. In addition to being Past President of the Ohio Chapter IAEI, Tim currently serves as the Secretary/Treasurer for Ohio Chapter, Western Section and International Membership Chair and Alternate to the International Board of Directors for the Western Section.
